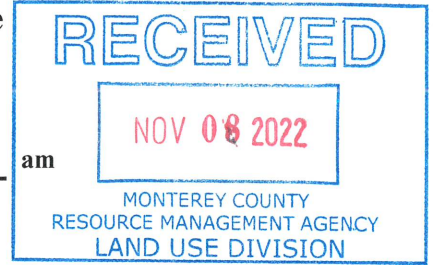

1. **Item Title:** AB 361 FINDING  
**Description:** On September 16, 2021, Governor Newsom signed AB 361. This legislation amends the Brown Act to allow meeting bodies subject to the Brown Act to meet via teleconference during a proclaimed state of emergency in accordance with teleconference procedures established by AB 361. For the December 13<sup>th</sup> remote meeting, the LUAC must make the findings.

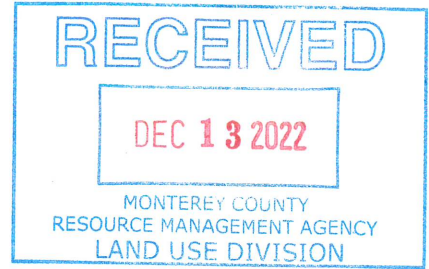

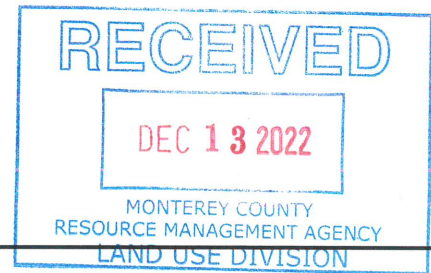
