

**AMENDMENT #1-2020 TO AGREEMENT BY AND BETWEEN
COUNTY OF MONTEREY & RELX INC**

THIS AMENDMENT is made to the non-standard AGREEMENT No. 14563 for the provision of Accurint for Government Transactional Debtor Location and Research Services by and between RELX INC, hereinafter “CONTRACTOR”, and the County of Monterey Treasurer-Tax Collector - Revenue Division, a political subdivision of the State of California, hereinafter referred to as “County”.

WHEREAS, the County and CONTRACTOR entered into an Agreement for the provision of Accurint for Government - Revenue - Transactional Debtor Location and Research Services to be performed under the terms of the State of California negotiated Standard Agreement No. 5-17-70-12, for the period of December 1, 2019 through December 31, 2020, in an amount of \$2,500;

WHEREAS, the County used the services more than anticipated, requiring additional funding on an annual basis.

WHEREAS, the County and CONTRACTOR desire to amend the AGREEMENT No. 14563 to increase the maximum dollar amount of the AGREEMENT for the provision of Accurint for Government - Revenue - Transactional Debtor Location and Research Services for the period December 1, 2019 through December 31, 2020 by \$10,500 for a total annual cost not to exceed of \$13,000;

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. The County and CONTRACTOR wish to amend the non-standard Accurint for Government - Revenue - Transactional Debtor Location and Research Services AGREEMENT for the period December 1, 2019 through December 31, 2020 to reflect a new annual contract amount not to exceed of \$13,000 for that period.
2. Except as provided herein, all remaining terms, conditions, provisions, entitlements and obligations of the original AGREEMENT shall remain unchanged and unaffected by this AMENDMENT and shall continue in full force and effect.
3. A copy of this AMENDMENT shall be attached to the original AGREEMENT dated November 19, 2019.
