Resolution of the Monterey County Board of Supervisors approving the request for Caltrans to replace missing No Parking At Any Time (R26A (CA)) signs on State Route One (SR1) in the vicinity of Point Lobos State Park; and authorize RMA-Director of Public Works and Facilities to forward an executed copy of the Resolution to Caltrans

RECITALS

WHEREAS, the Resource Management Agency received multiple expressions of concern to replace missing No Parking At Any Time signs on State Route 1(SR-1) near the entrance of Point Lobos State Park where park patrons park on the east side and cross SR-1 to access the park; and

WHEREAS, the Resource Management Agency determined that No Parking At Any Time sign placement on the east and west side of SR-1 for a distance of approximately 3600 feet (1800 feet north of Point Lobos State Park entrance to 1800 feet south of the entrance) would eliminate this issue.

NOW, THEREFORE, BE IT RESOLVED THAT, the Board of Supervisors of the County of Monterey does hereby approve the request for Caltrans to replace missing No Parking At Any Time (R26A (CA)) signs on State Route One (SR1) in the vicinity of Point Lobos State Park on the east and west side of SR-1 for a distance of approximately 3600 feet (1800 feet north of Point Lobos State Park entrance to 1800 feet south of the entrance); and authorize RMA-Director of Public Works and Facilities to forward an executed copy of the Resolution to Caltrans.
