WHEREAS, Natividad Medical Center (NMC) administration staff requested a base wage compensation study of the Hospital Medical Interpreter classification series; and

WHEREAS, NMC conducted a base wage compensation study of the Hospital Medical Interpreter classification which determined Hospital Medical Interpreter is approximately 22.85% below the mean of the County's comparable agencies and it is recommended to adjust the base wage salary of Hospital Medical Interpreter by the approximate percentage identified at top step; and

WHEREAS, NMC further recommends adjusting the base wage salary of Hospital Medical Interpretation Coordinator by approximately 22.85% at top step in order to maintain the spread of the series; and

WHEREAS, NMC also recommends the addition of allocations to Interpreter Services department to address increasing demands of the expanding services and ensure the equitable treatment of patients; and

WHEREAS, to implement the recommendations, the actions require the Personnel Policies and Practices Resolution No. 98- 394 Appendix A to be amended; NOW, THEREFORE,
