AMENDMENT #1 TO SERVICES AGREEMENT COUNTY OF MONTEREY & SUNLITE AUTO GLASS, INC.

THIS AMENDMENT NO. 1 is made to the AGREEMENT for glass installation, rock chip repair and headlight restoration services by and between SUNLITE AUTO GLASS, INC., hereinafter "CONTRACTOR", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "COUNTY."

WHEREAS, the Agreement between the County and CONTRACTOR entered into a Standard Agreement on *November 16, 2018*, (hereinafter, "Agreement") with a term of agreement date from *July 1, 2018 through July 31, 2021* and a "not to exceed" amount of *\$70,000*; and

WHEREAS, the County and CONTRACTOR discovered that certain services, which were intended to be covered in the original AGREEMENT, were not in fact sufficiently provided for in the AGREEMENT; and

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT via Amendment No. 1 to increase funds by \$30,000 for a new AGREEMENT amount not to exceed of \$100,000.00.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

- 1. Section 2. "PAYMENT PROVISIONS" shall be amended by removing, "The total amount payable by County to CONTRACTOR under this Agreement is not to exceed the sum of \$70,000.00" and replacing it with "The total amount payable by County to CONTRACTOR under this AGREEMENT is not to exceed the sum of \$100,000.00"
- 2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
- 3. A copy of *AMENDMENT NO. 1* shall be attached to the original AGREEMENT executed by the County on *November 16, 2018*.
