WHEREAS, the California Political Reform Act, Government Code sections 87300-87313, requires each public agency in California to adopt a conflict of interest code;

WHEREAS, the Governing Board of the Greenfield Union School District has previously adopted a conflict of interest code, by way of Board Bylaw 9270;

WHEREAS, a regulation adopted by the Fair Political Practices Commission, 2 CCR 18730, provides that incorporation by reference of the terms of that regulation, along with an public agency-specific appendix designating positions and disclosure categories shall constitute the adoption and amendment of a conflict of interest code in conformance with Government Code sections 87300 and 87306;

WHEREAS, the Greenfield Union School District has recently reviewed its positions, and the duties of each position, and has determined that changes to the current Conflict of Interest Board Bylaw 9270 are necessary;


WHEREAS, the amended Conflict of Interest Board Bylaw 9270 is attached as Exhibit A to this resolution;

WHEREAS, any earlier resolutions, bylaws and/or appendices containing the District's conflict of interest code shall be rescinded and superseded by this resolution and the amended Conflict of Interest Board Bylaw 9270; and

NOW THEREFORE, BE IT RESOLVED that the Greenfield Union School District Governing Board adopts the amended Conflict of Interest Board Bylaw 9270, including its Appendix of designated employees and disclosure categories.

#### **Staff Analysis:**

The Political Reform Act requires that each public agency in California review its Conflict of Interest Code on a biennial basis. The designated positions in Board Bylaw 9270's Appendix have been updated to include positions in which employees have the discretion to make decisions which could foreseeably have a material impact on economic interests. Additional language has also been added pursuant to the conflict of interest provisions found in the Government Code and the California Code of Regulations. The adopted Conflict of Interest Board Bylaw 9270 will be forwarded to the Monterey County Board of Supervisors for its approval.
