- b. Approve a Coastal Administrative Permit and Design Approval to allow construction of a 636-square-foot addition to an existing single-family dwelling and a Coastal Administrative Permit to allow development within 750 feet of known archaeological resources.

SUMMARY

Staff is recommending approval of two Coastal Administrative Permits and a Design Approval subject to the findings and evidence in the attached Resolution (see **Exhibit A**), and subject to the conditions of approval attached to the Resolution. Unless otherwise noted in the conditions, the applicant will be required to satisfy all permit conditions prior to the issuance of a building/grading

Note: This project will be referred to the Monterey County Zoning Administrator if a public hearing is necessary. The decision on this project is appealable to Board of Supervisors and the California Coastal Commission.
