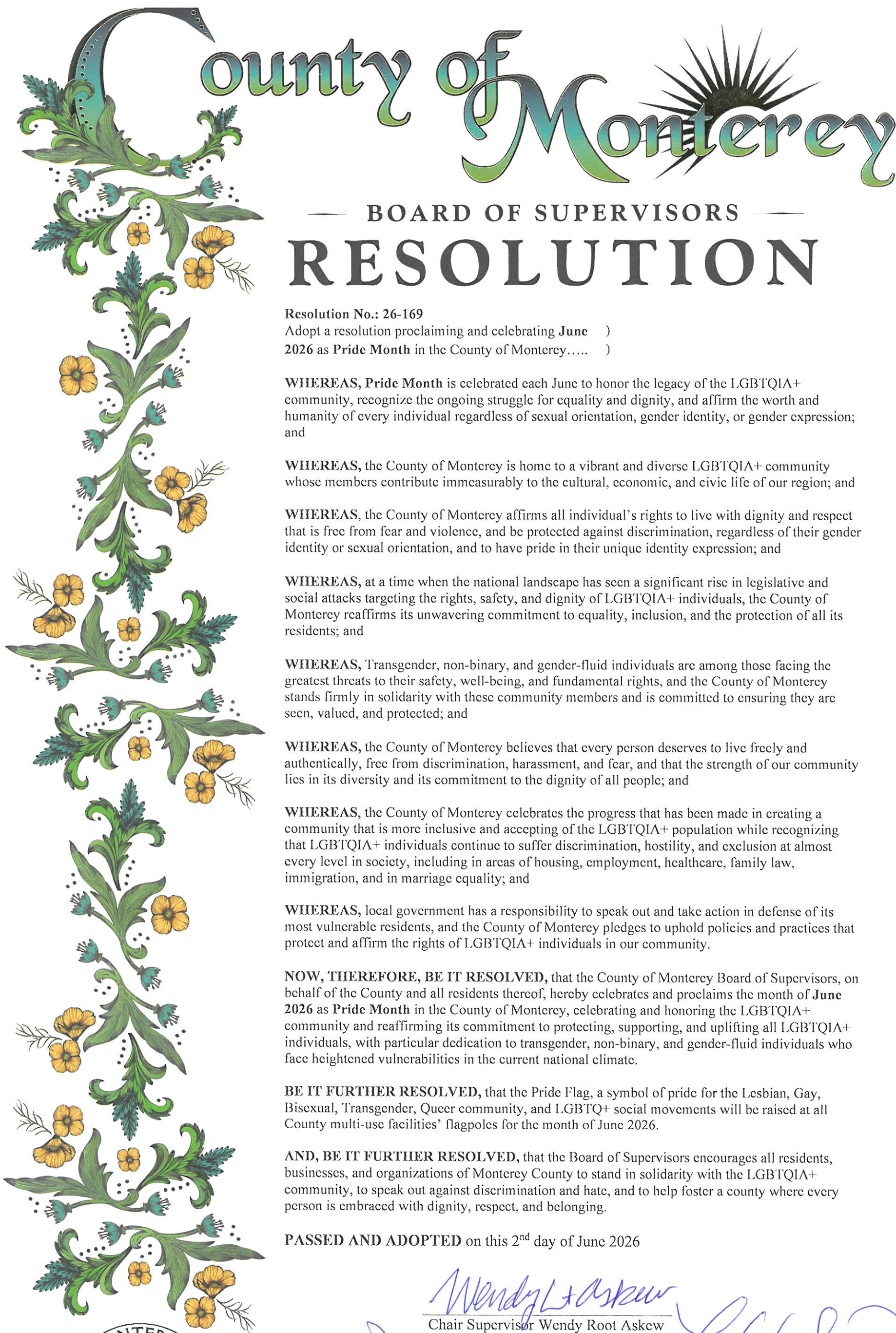

Adopt a resolution proclaiming and celebrating **June**)
2026 as Pride Month in the County of Monterey.....)

WHEREAS, **Pride Month** is celebrated each June to honor the legacy of the LGBTQIA+ community, recognize the ongoing struggle for equality and dignity, and affirm the worth and humanity of every individual regardless of sexual orientation, gender identity, or gender expression; and

WHEREAS, the County of Monterey is home to a vibrant and diverse LGBTQIA+ community whose members contribute immeasurably to the cultural, economic, and civic life of our region; and

WHEREAS, the County of Monterey affirms all individual's rights to live with dignity and respect that is free from fear and violence, and be protected against discrimination, regardless of their gender identity or sexual orientation, and to have pride in their unique identity expression; and

WHEREAS, at a time when the national landscape has seen a significant rise in legislative and social attacks targeting the rights, safety, and dignity of LGBTQIA+ individuals, the County of Monterey reaffirms its unwavering commitment to equality, inclusion, and the protection of all its residents; and

WHEREAS, Transgender, non-binary, and gender-fluid individuals are among those facing the greatest threats to their safety, well-being, and fundamental rights, and the County of Monterey stands firmly in solidarity with these community members and is committed to ensuring they are seen, valued, and protected; and

WHEREAS, the County of Monterey believes that every person deserves to live freely and authentically, free from discrimination, harassment, and fear, and that the strength of our community lies in its diversity and its commitment to the dignity of all people; and

WHEREAS, the County of Monterey celebrates the progress that has been made in creating a community that is more inclusive and accepting of the LGBTQIA+ population while recognizing that LGBTQIA+ individuals continue to suffer discrimination, hostility, and exclusion at almost every level in society, including in areas of housing, employment, healthcare, family law, immigration, and in marriage equality; and

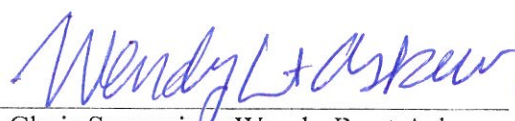
WHEREAS, local government has a responsibility to speak out and take action in defense of its most vulnerable residents, and the County of Monterey pledges to uphold policies and practices that protect and affirm the rights of LGBTQIA+ individuals in our community.

NOW, THEREFORE, BE IT RESOLVED, that the County of Monterey Board of Supervisors, on behalf of the County and all residents thereof, hereby celebrates and proclaims the month of **June 2026 as Pride Month** in the County of Monterey, celebrating and honoring the LGBTQIA+ community and reaffirming its commitment to protecting, supporting, and uplifting all LGBTQIA+ individuals, with particular dedication to transgender, non-binary, and gender-fluid individuals who face heightened vulnerabilities in the current national climate.

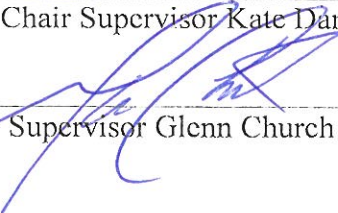

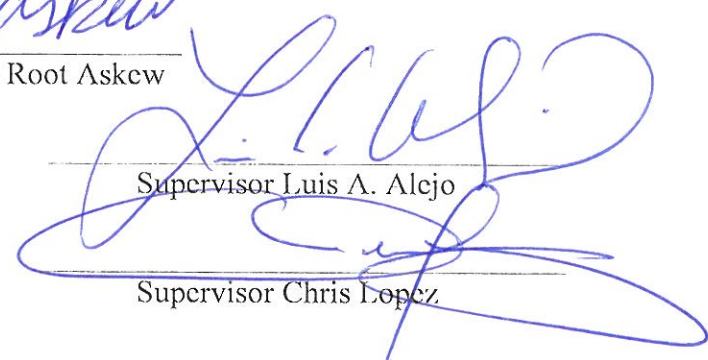

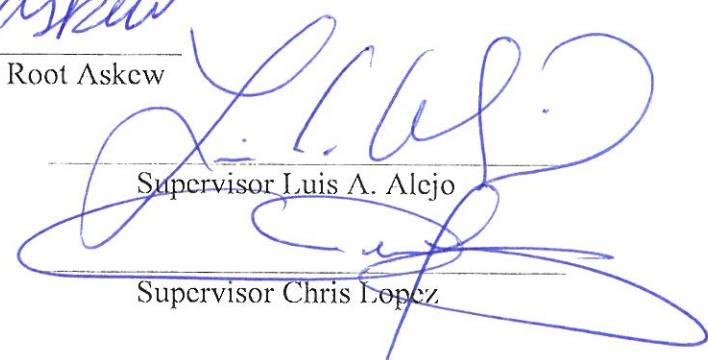
