AMENDMENT No. 1 TO PARAMEDIC SERVICE PROVIDER AGREEMENT BETWEEN COUNTY OF MONTEREY AND CITY OF SALINAS

THIS AMENDMENT No. 1 is made to the Paramedic Service Provider Agreement ("AGREEMENT") by and between the City of Salinas hereinafter referred to as "PROVIDER," and the County of Monterey, a political subdivision of the State of California, acting through its Emergency Medical Services Agency (EMSA), hereinafter referred to as "COUNTY."

WHEREAS, on or about July 19, 2022, COUNTY and PROVIDER entered into an AGREEMENT for the provision of paramedic services in the County of Monterey for a period from July 31, 2022 to July 31, 2025; and

WHEREAS, COUNTY and PROVIDER wish to amend the AGREEMENT to extend the AGREEMENT on the same terms and conditions for a period of three years to July 31, 2028.

NOW THEREFORE, COUNTY and PROVIDER hereby agree to amend the AGREEMENT in the following manner:

- 1. Section 1 of Term of Agreement shall be amended by removing "Once signed by the authorized representatives for all parties, this Agreement becomes effective at 8:00 a.m. on July 31, 2022 and shall continue until July 31, 2025," and replacing it with "Once signed by the authorized representatives for all parties, this agreement becomes effective at 8:00 a.m. on July 31, 2022 and shall continue until July 31, 2028."
- 2. The title, first paragraph and footer of agreement is being amended as follows: Replace "Paramedic Service Provider Agreement" to "First Response Paramedic Service Provider Agreement."
- 3. First paragraph of the General Scope section is being amended as follows: Replace "the PROVIDER does not waive or modify any present rights under state by its execution of this Agreement" with "the PROVIDER does not waive or modify any present or future rights under any statute or agreement by its execution of this Agreement."
- 4. Section 2.3 is being amended as follows: Replace "This Agreement does not authorize PROVIDER to offer or provide medical transportation services separate of an Exclusive Operating Area (EOA) with recognized 201 Rights." with "This Agreement does not authorize PROVIDER to offer or provide medical transportation services."
- 5. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT shall continue in full force and effect.
- 6. A copy of AMENDMENT No. 1 shall be attached to the original AGREEMENT dated July 31, 2018 and shall be incorporated therein as if fully set forth in the AGREEMENT.
