WHEREAS, the Board of Supervisors desires to implement similar base salary increases and the Winter Recess for unrepresented Units P, X, XL, Y and Z for 2017; and

WHEREAS, the actions require the Personnel Policies and Practices Resolution No. 98-394 to be amended; NOW, THEREFORE,

BE IT RESOLVED by the Board of Supervisors in and for the County of Monterey as follows:

1. Consistent with Section A.1.10 of the Personnel Policies and Practices Resolution (PPPR) No. 98-394, the Board of Supervisors received notification that Appendix A of the PPPR will be amended to reflect a 2.5% base salary increase for Units P and Z effective the first full pay

- period following July 1, 2017, and a 3% increase the first full pay period following July 1, 2018;
- 2. Appendix A of Personnel Policies and Practices Resolution No. 98-394 is amended to add a 2.5% base salary increase for Units X, XL and Y effective the first full pay period following July 1, 2017;
- 3. The Winter Recess is approved for Units P, X, XL, Y and Z (excluding elected officials in Unit Y);
- 4. The Auditor-Controller is hereby authorized and the Human Resources Department is directed to implement these changes in the Advantage HRM System.
