**WHEREAS**, The American Legion Honor Guard provides military funeral services designed to honor the lives of County Veterans who served their Country in the Armed Forces, their families, and their survivors for the past 45 years;

**WHEREAS**, the Honor Guard voluntarily covers the Tri-County area with funeral services, sometimes conducting up to three a day, and up to six days straight and holds a firm "Never turn a Veteran down" attitude;

**WHEREAS**, the original District 28 Honor Guard was formed in 1970 at the VFW 5789 in Salinas and today the tradition is carried on through American Legion Post 31;

**WHEREAS**, the 2015 District 28 Honor Guard registered 2100 volunteer hours conducting funeral services, legion kitchen assistance, and fundraisers;

**WHEREAS**, the 2015 District 28 Honor Guard financially relied solely on donations and internal fundraisers to absorb the costs of maintenance of equipment, transportation, uniforms, and purchase of flags for funeral services;

**WHEREAS**, in 2015 there were fourteen active members of the District 28 Honor Guard, and today we have three retired, and two deceased; all of the Honor Guard members are Veterans from all the Armed Forces;
