Re: Extension of County of Monterey Agreement for Professional Services

Ms. Gentile:

This Letter Agreement (the "Letter Agreement") sets forth a binding agreement by and between COUNTY OF MONTEREY ("County") on behalf of NATIVIDAD MEDICAL CENTER ("Hospital") and STAFF CARE INC. ("Contractor"), regarding the extension and continuation of the Agreement for Professional Services between Hospital and Contractor dated February 1, 2009; as amended July 1, 2010; July 1, 2011; July 1, 2012; July 1, 2013 and July 1, 2014 (collectively the "Existing Agreement").

- 1. Extension of Term. The parties hereby agree to extend the term of the Existing Agreement not to exceed thirty-one (31) days from the expiration date set forth in the Existing Agreement through July 31, 2015 (the "Extension Period").
- 2. <u>Continuation of Existing Agreement</u>. Except as specifically amended by this Letter Agreement, during the Extension Period, the Existing Agreement shall continue in full force and effect, and Contractor shall continue **to provide referrals of locum tenens providers** and otherwise comply with the terms and conditions of the Existing Agreement as existing on the date of this Letter Agreement.
- 3. <u>Conflicts</u>. In the event of any conflict between the terms and provisions of this Letter Agreement and the terms and provisions of the Existing Agreement, the terms and provisions of this Letter Agreement shall control.
- 4. <u>Reference</u>. The terms and provisions of this Letter Agreement are incorporated by this reference in the Existing Agreement as though fully set forth in the Existing Agreement. After the date of this Letter Agreement, any reference to the Existing Agreement shall mean the Existing Agreement as amended by this Letter Agreement.
- 5. <u>Counterparts</u>. This Letter Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
