WHEREAS, *Kathy Merritt* is a member of Silver Kings and Queens, where she is in charge of rounding up all of the "King City Pie Makers" for the MCARLM Clam Chowder Feed every year, numerous community members are familiar with Kathy's baking skills, including her famous lemon delight that she whips up for one hundred-fifty people for many of the local fundraisers; and
