SUMMARY:

The Elections Department requests the Board of Supervisors receive the Statement of Votes Cast at the November 4, 2025, Statewide Special Election within Monterey County, as certified by the Registrar of Voters.

DISCUSSION:

In accordance with Elections Code section 15372, the Registrar of Voters is submitting the certified Statement of Votes Cast to your Board. Pursuant to Elections Code section 15374, the Statement of Votes Cast shows:

- ☐ the total number of ballots cast;
- ☐ the number of votes cast at each precinct for and against the proposition;
- ☐ the total number of votes cast for and against the proposition;
- ☐ the total number of votes cast in each city, assembly district, congressional district, senatorial district, State Board of Equalization district, and supervisorial district located in whole or in part in the County, for the proposition voted on within the state.

The Elections Department will also file a certified Statement of Votes Cast with the California Secretary of State who shall compile the statements of all 58 counties and certify the statewide results and each local jurisdiction with candidates and/or ballot measures on the ballot, Exhibit A - Statement of Votes Cast.
