### RECOMMENDATION:

### SUMMARY/DISCUSSION:

At the Board of Supervisors meeting on November 10, 2015, the Board approved report 15-1227 that authorized County Staff to begin the Request for Proposal (RFP) process for the procurement of a new concession agreement to manage Mazda Raceway Laguna Seca. This was in response to the BOS Referral Number 2015.08. County staff has set six public meetings as listed below in order to solicit input from the general public.
