

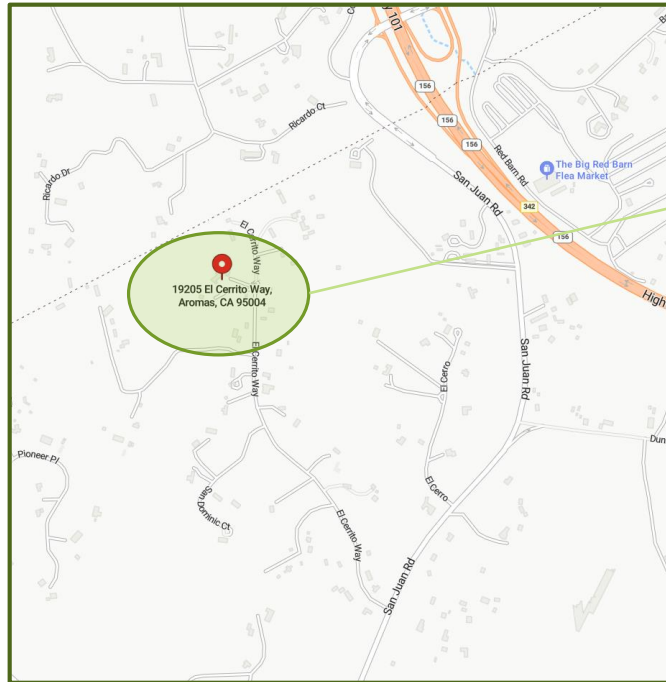

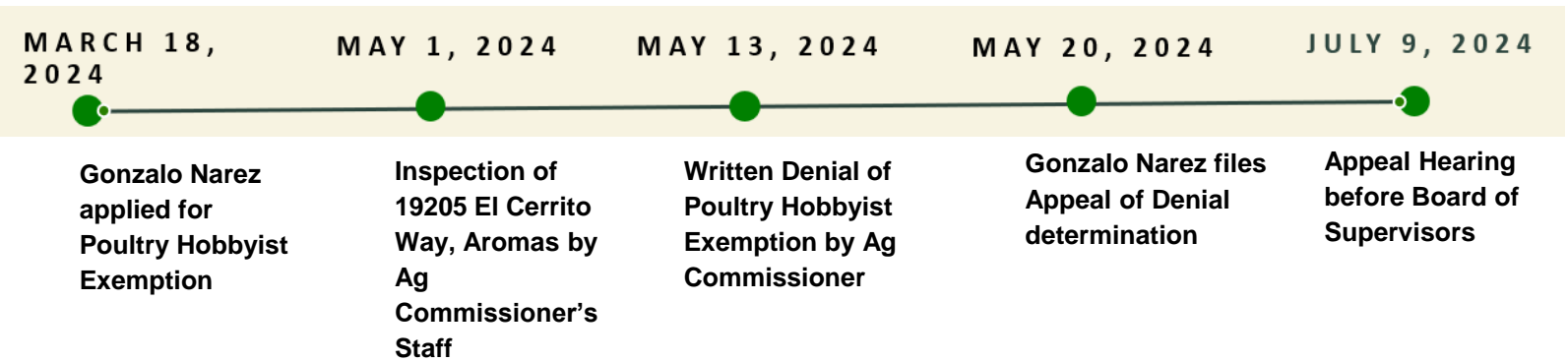

## Background/Process for keeping 5 or more roosters with a Poultry Hobbyist Exemption:

- ❑ **Rooster Ordinance: Adopted Dec. 2014**
- ❑ **Title 8- Animal Control: MCC 8.50- Requirements for Keeping Five or More Roosters**
- ❑ **Rooster Keeping Operation Permit with County Animal Services – unless an exemption is granted**
- ❑ **Poultry Hobbyist Exemption is processed by Agricultural Commissioner's Office (MCC 8.50.110)**
- ❑ **Agricultural Commissioner review-**
  - Requisite criteria including **Poultry Hobbyist** definition
  - Review of application & materials
  - Performs site visit of the property
- ❑ **Approval if it meets requisite criteria-**
  - Written approval notification to Applicant & County Animal Services
  - County Animal Services maintains records of exemption
  - Exemption valid for 5 years
- ❑ **Denial if it does not meet requisite criteria-**
  - Written denial notification to Applicant & County Animal Services
  - Applicant must apply and obtain a *Rooster Keeping Operation Permit* from County Animal Services
  - Applicant has right to appeal decision

## GONZALO NAREZ – TIMELINE OF POULTRY HOBBYIST EXEMPTION REQUEST



Definition: "**Poultry hobbyist**" is a person who is recognized by the Agricultural Commissioner as a member of a local, state or national organization which promotes the breeding of poultry for exhibition or show and/or sale of poultry to promote breeding as a hobby. **The term "poultry hobbyist" does not include persons who raise poultry for the purpose of making them available for cockfighting.**

(MCC 8.04.010)

Agricultural Commissioner must find the request for Poultry Exemption meets the requisites pursuant to MCC 8.50.110:

- ❑ Definition of Poultry Hobbyist
- ❑ Review of application packet, including:
  - # of roosters and breeds
  - No criminal convictions for illegal cockfighting or other crime of animal cruelty; no raising of roosters for cockfighting
  - Proof of hobbyist affiliations, such as hobbyist association membership documentation, show entries and results
- ❑ Inspection of property where exemption is being sought

## Basis for Denial of Poultry Hobbyist Exemption

- Appellant's membership in the *California Association for the Preservation of Game Fowl Breeders Association* or *UGBA*
  - Agricultural Commissioner does not recognize the UGBA as a legitimate poultry hobbyist organization because it promotes the right to keep and fight cockfighting birds.
- No evidence was submitted by the Appellant of active involvement in poultry hobbyist shows with entries and/or awards through the listed affiliations in his application.
- Inspection of the property at 19205 El Cerrito Way, Aromas
  - Vast majority of birds were roosters and a few hens.
  - Large male to female ratio suggests breeding is limited and promoting breeding of the birds is not a focus with this operation.
  - Roosters on premises are the variety used in cock fighting.
  - Some roosters were dubbed and their spurs trimmed which is how cock fighting roosters are customarily groomed.
- Consultation with County Health Animal Services
  - Previous denial of Rooster Keeping Operation Permit.

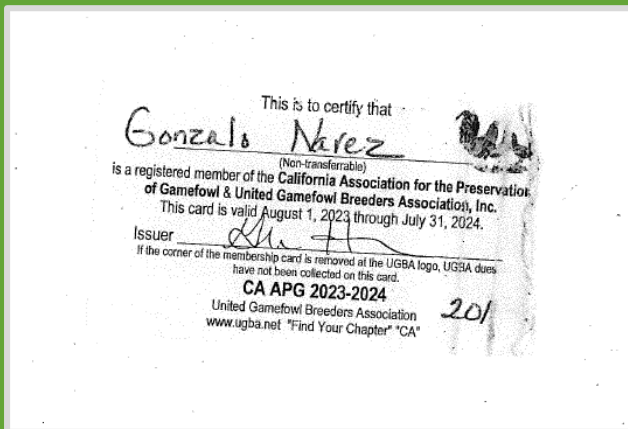

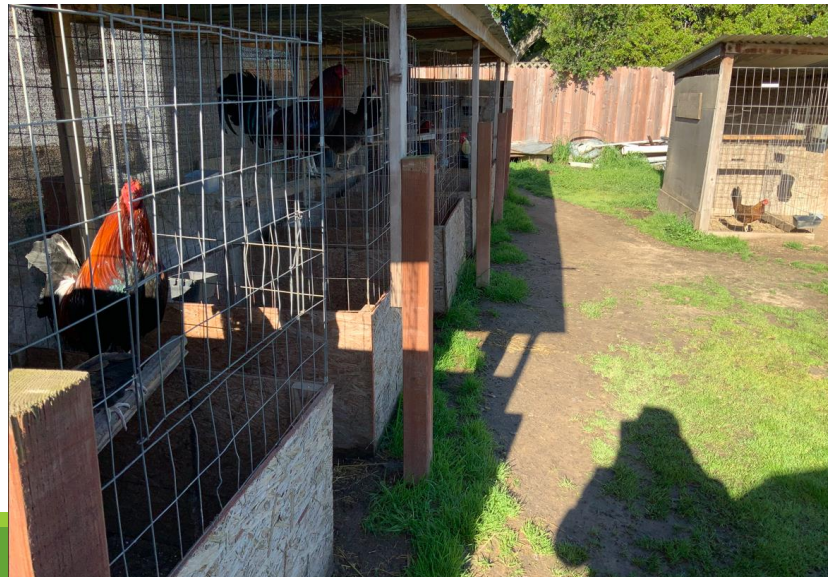


## What are Gamefowl?

The gamefowl heritage can be traced to the Red Jungle Fowl the ancestor of domesticated chickens. Jungle fowl- any of four Asian birds of the genus Gallus, family Phasianidae (order Galliformes). Gallus species differ from other members of the pheasant family in having, in the male, a fleshy comb, lobed wattles hanging below the bill, and high-arched tail. The red jungle fowl (*G. gallus*) is the ancestor of the domestic fowl. The cock has shining silky plumage, red on the head and back and green-black elsewhere—a pattern seen also in several domestic breeds. The hen is rusty brown with speckled neck and minimal comb. **Males meet in a selected arena—natural precursor of the gamecock pit, where they use their sharp leg spurs in combat, often to the death.** In courtship display, the male drops one wing and tilts his head, mantle, and back—his most colorful parts—toward the hen; the domestic rooster behaves similarly. Jungle fowl seem to be monogamous under normal circumstances. The hen lays 5–8 buff colored eggs in a clutch before setting.

In this picture you see the rooster is dubbed and the spurs has been cut, making them dubbed. This is done to this length for the intent to fight the rooster with a gaff or knife. It is placed on the spur of the leg of the rooster.





**Dubbed rooster, meaning the comb and wattles have been removed. This makes the rooster look like it was scalped. Dubbing this close to the rooster's skull is only seen in Roosters where the intent is to fight them.**

# Examples of Roosters used for fights. These are not photographs of the Narez roosters.



Picture of how knives are attached to spur on roosters' legs. If the spur was not cut, it would interfere with the knife/gaff placement.

- 3) Deny the Gonzalo Narez Poultry Hobbyist Exemption request.
