

**AMENDMENT NO. 1  
TO AGREEMENT BY AND BETWEEN  
COUNTY OF MONTEREY AND  
UNIVERSITY OF PITTSBURGH – OF THE  
COMMONWEALTH SYSTEM OF HIGHER  
EDUCATION**

**THIS AMENDMENT NO. 1** to the Agreement is made by and between the County of Monterey, a political subdivision of the State of California (hereinafter referred to as "County"), and the University of Pittsburgh – of the Commonwealth System of Higher Education (hereinafter referred to as "CONTRACTOR") with respect to the following.

**WHEREAS**, on April 8, 2024, County and CONTRACTOR entered into an Agreement at no cost to the County, for the term of April 12, 2024, through April 11, 2025, for the provision of access to the National Retail Data Monitor (NRDM), a public health surveillance tool created by the University of Pittsburgh that collects and analyzes over-the-counter drug sales to identify disease outbreaks; and

**WHEREAS**, County and CONTRACTOR wish to amend the Agreement to entitle 10 users to access the National Retail Data Monitor (NRDM), and sign Exhibit A, "Authorization User",

**NOW THEREFORE**, County and CONTRACTOR hereby agree to amend the Agreement in the following manner:

1. Exhibit A shall be amended to include 10 "Authorized Users" to be designated by the parties pursuant to Section 1, subpart (b) of the agreement.
2. Except as provided herein, all remaining terms, conditions, and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
3. A copy of this Amendment No. 1 shall be attached to the original Agreement executed by the County on April 8, 2025.
