

**AMENDMENT NO. 3
TO AGREEMENT BY AND BETWEEN
THE COUNTY OF MONTEREY AND
THERMO ELECTRON NORTH AMERICA,
LLC**

THIS AMENDMENT NO. 3 to the Agreement is made by and between the COUNTY of Monterey, a political subdivision of the State of California (hereinafter referred to as "COUNTY"), and **Thermo Electron North America, LLC.**, (hereinafter referred to as "CONTRACTOR") with respect to the following.

WHEREAS, on January 12, 2024, COUNTY and CONTRACTOR entered into an Agreement No. A-16677 in the amount of \$170,522.40 for the term January 12, 2024, through December 31, 2027, for the provision of lab equipment, installation, and preventative maintenance; and

WHEREAS, on March 11, 2024, COUNTY and CONTRACTOR entered into Amendment No.1 in the amount of \$171,628.32 due to an increase in cost, with no change in terms; and

WHEREAS, on May 2, 2024, COUNTY and CONTRACTOR entered into an Amendment No.2, decreasing the total Agreement by \$657.97 due to a decrease in cost, for a total aggregate amount not to exceed \$170,970.35; and

WHEREAS, COUNTY and CONTRACTOR wish to increase the funds by \$63,435.78 for the purchase of laboratory equipment and preventative maintenance for a total aggregate amount not to exceed \$234,406.13, replace Exhibit A-2 with Exhibit A-3, reflecting the updated Scope of Services, and extend the term for one (1) additional year, for a new term of January 12, 2024, through December 31, 2028; and

NOW THEREFORE, COUNTY and CONTRACTOR hereby agree as follows:

1. **Paragraph 2.0, "Payment Provisions," shall be amended by removing** "The total amount payable by COUNTY to CONTRACTOR under this Agreement is not to exceed the sum of \$170,970.35" **and replacing it with** "The total amount payable by COUNTY to CONTRACTOR under this Agreement is not to exceed the sum of \$234,406.13."
2. EXHIBIT A-2 Scope of Services/Payment Provisions is deleted and replaced in its entirety with Exhibit A-3 Scope of Services/Payment Provisions. All References in the Agreement to EXHIBIT A-2 shall be construed to refer to EXHIBIT A-3 Scope of Services/Payment Provisions.
3. Except as provided herein, all remaining terms, conditions, and provisions of the Agreement are unchanged and unaffected by this Amendment No. 3 and shall continue in full force and effect as set forth in the Agreement.

Scope of Services / Payment Provisions

A. SCOPE OF SERVICES

- A.1** CONTRACTOR shall provide services and staff, and otherwise do all things necessary for or incidental to the performance of work, as set forth below:
- A.1.2** CONTRACTOR shall install BRE731344 iCAP RQplus (C1, iMR) AGD iCAP RQplus iMR Quadrupole ICP-MS Spectrometer with 1 QCell MFC and Argon Gas, with a 12-month base warranty.
- A.1.3** CONTRACTOR shall provide Extended Warranty Promo-iCAP RQ+, for an additional two years that will begin after the 12-month base warranty ends; on-site corrective maintenance visits, including required factory certified replacement parts, labor, and travel with a target of three (3) business day on-site response time; Annual Standard Preventive Maintenance visit and a Standard Preventive Maintenance Kit Priority status for technical support telephone inquiries; and 10% discount on spare parts (not covered by corrective maintenance), accessories and consumables.
- A.1.4** CONTRACTOR shall install a Dionex Inuvion RFIC system with AS-DV autosampler, provide extended warranty for two additional years and a 12-month on-site corrective maintenance visits, including required factory certified replacement parts and labor with a target of three (3) business day on-site response time; an Annual Standard Preventive Maintenance visit and a Standard Preventive Maintenance Kit; Priority status for technical support telephone inquiries; and 10% discount on spare parts (not covered by corrective maintenance), accessories and consumables.

B. PAYMENT PROVISIONS

B.1 COMPENSATION/ PAYMENT

COUNTY shall pay an amount not to exceed **\$234,406.13** for the performance of all things necessary for or incidental to the performance of work as set forth in the Scope of Services. CONTRACTOR'S compensation for services rendered shall be based on the following rates or in accordance with the following terms:

B.2 CONTRACTORS BILLING PROCEDURES

NOTE: Payment may be based upon satisfactory acceptance of each deliverable, payment after completion of each major part of the Agreement, payment at conclusion of the Agreement.

COUNTY may, in its sole discretion, terminate the contract or withhold payments claimed by CONTRACTOR for services rendered if CONTRACTOR fails to satisfactorily comply with any term or condition of this Agreement.

No payments in advance or in anticipation of services or supplies to be provided under this Agreement shall be made by COUNTY.

COUNTY shall not pay any claims for payment for services submitted more than twelve (12) months after the calendar month in which the services were completed.

DISALLOWED COSTS: CONTRACTOR is responsible for any audit exceptions or disallowed costs incurred by its own organization or that of its subcontractors.

- b) Bear the Contractor's name as shown on the agreement.

- d) Identify the billing and/or performance period covered by the invoice.
- e) Itemize costs for the billing period in the same detail as indicated in the scope of services in the agreement. Reimbursement may only be sought for those costs and/or cost categories expressly identified as allowable in this agreement and approved by the County of Monterey.
