**AMENDMENT NO. 2
TO
STANDARD AGREEMENT
BETWEEN
COUNTY OF MONTEREY
AND
SUNBELT RENTALS INC.**

THIS AMENDMENT NO. 2 (Amendment) is made to the Standard Agreement between the County of Monterey, a political subdivision of the State of California (“County”) and Sunbelt Rentals Inc. (hereinafter, “Contractor”) (collectively, the “Parties”) and effective as of the last date opposite the respective signatures below.

WHEREAS, the Parties entered into a **Standard Agreement** on May 2, 2023 (the “Agreement”) to allow Contractor to provide heavy equipment rentals (the “Services”); and

WHEREAS, the Parties amended said Agreement through Amendment No. 1 dated December 5, 2023 to increase the not to exceed sum; and

WHEREAS, the Parties wish to further amend the Agreement to increase the not to exceed sum.

NOW, THEREFORE, the Parties hereby agree to amend the Agreement as follows:

1. Section 2, “Payment Provisions” is deleted in its entirety and replaced with:

“County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$451,000.00”.
2. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect as set forth in the Agreement.
3. This Amendment No. 2 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.

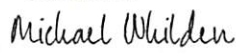
