## **ORDINANCE NO. 5279**

AN ORDINANCE OF THE COUNTY OF MONTEREY, STATE OF CALIFORNIA, AMENDING SECTION 12.24.020 OF THE MONTEREY COUNTY CODE RELATING TO STOP INTERSECTIONS.

## **County Counsel Summary**

This ordinance amends section 12.24.020 of the Monterey County Code to establish a stop intersection on Bishop Street at Florence Street, on Cayetano Street at Florence Street, and at Jonathan Street at Florence Street in Pajaro, an unincorporated area of the County of Monterey.

The Board of Supervisors of the County of Monterey ordains as follows:

SECTION 1. PURPOSE AND FINDINGS. Pursuant to Article XI, section 7 of the California Constitution, the County of Monterey may adopt and enforce ordinances and regulations not in conflict with general laws to protect and promote the public health, safety, and welfare of its citizens. California Vehicle Code section 21354 authorizes the County of Monterey to designate highways under its jurisdiction as through highways and erect stop signs at all entrances thereto or to designate any intersection under its exclusive jurisdiction as a stop intersection and erect stop signs at one or more entrances thereto.

SECTION 2. Section 12.24.020 of the Monterey County Code is amended to add the following paragraph:

Intersection of Bishop Street and Florence Street. Stop required on Bishop Street at the northeast entrance to Florence Street.

Intersection of Cayetano Street at Florence Street. Stop required on Cayetano Street at the southwest entrance to Florence Street.

Intersection of Jonathan Street at Florence Street. Stop required on Jonathan Street at the southeast entrance to Florence Street.

SECTION 3. This ordinance shall become effective on the thirty-first day following its adoption.
