

AMENDMENT NO. 1
to
MONTEREY COUNTY WATER RESOURCES AGENCY
and GEORESTORATION INC
AGREEMENT FOR PROFESSIONAL SERVICES

The Agreement for Professional Services, hereinafter called "Agreement," between the Monterey County Water Resources Agency, (WRA) and GeoRestoration, Inc., 15940 Concord Circle, Morgan Hill, California 95037, a California Corporation, hereinafter called "Contractor," dated November 23, 2009, is hereby modified by this Amendment No. 1.

The original Agreement required the WRA to pay Contractor a maximum amount of \$561,670 for services provided. This Amendment No. 1 adds \$1,690,632 to the total maximum amount for a total maximum amount of \$2,252,302 through Jun 30, 2017.

The original Agreement required the WRA to administer the contract. This Amendment No. 1 rescinds the WRA as party to the Agreement and designates the County of Monterey, Risk Management Division as the County Division hereby designated as the proper party to this contract, charged with oversight, direct payment and management of same.

The Agreement is amended as follows:

1. Section 3. should be changed to read as follows:

Section 3. Payments to Contractor, maximum liability: Subject to the limitations set forth herein, Agency shall cause County of Monterey, pursuant to paragraph 5 of *Agreement Re: Fuel Spill Clean-up Management Services*, dated 28 August 2012, to directly pay to Contractor the amounts provided in Exhibit A. The maximum amount payable to Contractor under this contract is **Two million, two hundred fifty-two thousand, three hundred and two dollars (\$2,252,302).**

2. The first sentence designating parties to this contract should be changed to read:

The Agreement between the County of Monterey Risk Management Division, and GeoRestoration Inc., 15940 Concord Circle, Morgan Hill, California 95037, a California Corporation, hereinafter called "Contractor."




