Adopt a Resolution to:

- a) Amend Personnel Policies and Practices Resolution No. 98-394 Appendix A to adjust the salary range of the Managed Care Operations Manager classification as indicated below effective August 26, 2023; and)
- b) Direct the Human Resources Department to implement the changes in the Advantage Human Resources Management System.)

WHEREAS, Natividad Medical Center (NMC) administration staff requested a base wage compensation study of the Managed Care Operations Manager; and

WHEREAS, NMC conducted a base wage compensation study of the Managed Care Operations Manager classification which determined Managed Care Operations Manager is approximately 77.00% below the mean of the County’s comparable agencies and it is recommended to adjust the base wage salary of the Managed Care Operations Manager by the approximate percentage identified at top step; and

WHEREAS, to implement the recommendation, the action requires the Personnel Policies and Practices Resolution No. 98- 394 Appendix A to be amended;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors in and for the County of Monterey as follows:

1. Personnel Policies and Practices Resolution (PPPR) No. 98-394 Appendix A is amended to adjust the salary range of the Managed Care Operations Manager classification as indicated below effective August 26, 2023:


