WHEREAS, Terry Peterson began her thirty-two-year career with Monterey County Department of Social Services on May 31, 1984 in the Seaside Office as an Eligibility Worker and went on to hold a variety of other positions throughout her career ending as a Departmental Information Systems Manager II; and

WHEREAS, Terry Peterson was promoted to Staff Development Specialist and was selected as a member of the department's Cypress Project Leadership Team established to assist the department in its transition to the Interim Statewide Welfare System (ISAWS); and

WHEREAS, Terry Peterson was promoted to Staff Services Analyst, in this capacity she acted as the ISAWS Change Management Analyst and this assignment included a great deal of travel outside of the county as she was assisting Humboldt County to document their current procedures and the work with county staff to complete the change analysis for the transition to the ISAWS system; and

WHEREAS, Terry Peterson was an instructor in the Hartnell Community College, Eligibility Classes; and

WHEREAS, Terry Peterson provided support to the Commission on the Status of Women and participated in the creation and implementation of several DSS programs such as *Walk in My Shoes, Random Acts of Kindness, and Peace Builders in the Workplace*; and

WHEREAS, Terry Peterson facilitated the Management Council's Professional Development committee and graduated from Leadership Monterey Peninsula; and

WHEREAS, Terry Peterson was called upon to assist with technology related projects such as the evaluation of the migration vendor proposals, systems maintenance proposals, and many other Information Technology related projects in her role as the ISAWS/C-IV County Project Manager; and

WHEREAS, Terry Peterson received Employee Recognition nomination for the DSS Network Conversion Team, received Employee Recognition Honorable Mention for Leadership, and received an Employee Recognition Award for as a member of the CMIPS II Implementation Team; and

WHEREAS, Terry Peterson has given back to her community through her spirit of volunteerism as a member of the Board of Directors for the Pacific Grove Feast of Lanterns, Family Service Agency of the Central Coast, Monterey County Suicide Prevention and Crisis

Center and Steering Committee Member of the Pacific Grove Young Entrepreneurs Award, and volunteered on the Monterey Jazz Festival, Special Olympics, and Rio Resolution Run Benefit.
