WHEREAS, County desires to cooperate with Franchisee and allow a 10-year extension, from May 17, 2021, through May 16, 2031 on the same terms and conditions previously agreed to in Resolution No. 00- 271 adopted by the Board of Supervisors of the County of Monterey on June 13, 2000.

NOW, THEREFORE, BE IT RESOLVED THAT, the Board of Supervisors of the County of Monterey hereby:

- 1. Grants to Franchisee subject to each and all of the terms and conditions described herein, the right, privilege, and franchise for ten years from May 17, 2021, through May 16, 2031 on the same terms and conditions previously agreed to in Resolution No. 00-271 adopted by the Board of Supervisors on June 13, 2000; and
- 2. Authorizes the Clerk of the Board to submit copies of this Resolution and Resolution No. 00-271 to the County Auditor-Controller for annual billing; and
- 3. Authorizes the County Auditor-Controller to allocate all fees collected through this franchise to the General Fund.
