Adopted Resolution honoring Reverend Alvin Davis, Pastor after more than 30 Years of Community Service within Monterey County. (Supervisor Armenta)



WHEREAS, *Reverend Alvin Davis*, at the young age of 17 enlisted into the United States Army where he served in the Vietnam War and received a *Purple Heart of Distinction*, then finally retired after 22 years of service; and

WHEREAS, following his military service, *Reverend Alvin Davis* matriculated through higher education to receive his *Associate of Arts* and *Bachelor of Arts* degrees in Liberal Studies. While attending college, he pledged and became a member of the nationally accredited Fraternity, Omega Psi Phi; and

WHEREAS, *Reverend Alvin Davis* began his career with the State of California as an employee of 24 years, serving under the Department of Employment as a Veteran's Employment Counselor, and in the Parole Employment. After his public service tenure with the State of California, *Reverend Alvin Davis* entered into retirement and enjoyed his time with his family; and

WHEREAS, *The Right Reverend Alvin Davis* continued his public service as a Civic Leader and Spiritual Advisor with the Community of Monterey County in which he resides. He has served as Pastor of the *Mount Nebo Missionary Baptist Church* for more than thirty two years. As Pastor, he has served three consecutive terms as an elected official for the *Salinas School District*, and served as President of the *California Association of Compensatory Education (CACE)* for two years, and also served on the Board of Directors of the local *Charitable Council*, and as President of the *Salinas Chapter of the Red Cross*; and

WHEREAS, *Reverend Alvin Davis* currently serves on both, the *Private Industrial Council (PIC)* and the *Workforce Investment Board (WIB)* for the County of Monterey; and

WHEREAS, *Reverend Alvin Davis*, has been happily married for 57 years to Mrs. Ethel Davis. Together they have three children, 15 grandchildren, and 12 great grandchildren.
