WHEREAS, Natividad Medical Center (NMC) administration staff requested a base wage compensation study of the Hospital Director of Environmental Services; and

WHEREAS, NMC conducted a base wage compensation study of the Hospital Director of Environmental Services classification which determined Hospital Director of Environmental Services is approximately 6.87% below the mean of the County’s comparable agencies and it is recommended to adjust the base wage salary of the Hospital Director of Environmental Services by the approximate percentage identified at top step; and

WHEREAS, to implement the recommendation, the action requires the Personnel Policies and Practices Resolution No. 98- 394 Appendix A to be amended; NOW, THEREFORE,

BE IT RESOLVED by the Board of Supervisors in and for the County of Monterey as follows:
