WHEREAS, Natividad Medical Center (NMC) administration staff requested a base wage compensation study of the Patient Financial Services Director classification; and

WHEREAS, NMC conducted a base wage compensation study of the Patient Financial Services Director classification which determined Patient Financial Services Director is approximately 5.16% below the mean of the County's comparable agencies and it is recommended to adjust the base wage salary of Patient Financial Services Director by the approximate percentage identified at top step; and

WHEREAS, to implement the recommendation, the action requires the Personnel Policies and Practices Resolution No. 98- 394 Appendix A to be amended;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors in and for the County of Monterey as follows:


