WHEREAS, THE County Service Area 23 - Carmel Rancho 1, 2, and 3 Subdivisions and Annexes ("Public Agency") requests that the Monterey County Auditor-Controller enter those general or special taxes, assessments, or property-related Fees or charges identified in Exhibit "A" on the tax roll for collection and distribution by the Monterey County Treasurer-Tax Collector commencing with the property tax bills for Fiscal Year 2015-16.
