Resolution to Approve the Amended Conflict of Interest Code of the Office of the County Counsel, County of Monterey)

WHEREAS, pursuant to the Political Reform Act of 1974, specifically Government Code sections 87300 and 87301, the Office of the County Counsel, County of Monterey has adopted a Conflict-of-Interest Code; and

WHEREAS, the Political Reform Act requires state and local government agencies to periodically review and make necessary changes to this code;

WHEREAS, since September 2023, when the Office of the County Counsel's Conflict-of-Interest Code was last amended, position and title changes have occurred, thus requiring amendment to reflect these changes;

WHEREAS, pursuant to Government Code section 87306, the Office of the County Counsel, County of Monterey has amended its Conflict-of-Interest Code as necessitated by changed circumstances;

WHEREAS, pursuant to Sections 82011 and 87303 of the Government Code, the Office of the County Counsel, County of Monterey submitted its amended code to the County of Monterey Board of Supervisors, the code reviewing body, for approval;

WHEREAS, the amended Conflict-of-Interest Code of the Office of the County Counsel, County of Monterey is attached hereto as Attachment A and is incorporated herein by reference;

WHEREAS, pursuant to Government Code section 87303, the Board of Supervisors as the code reviewing body may approve the code as submitted, may revise the proposed code and approve it as revised, or may return the proposed code to County Counsel for revision and resubmission;

WHEREAS, the proposed Conflict-of-Interest Code, as amended, is lawful under the Political Reform Act;

NOW, THEREFORE BE IT RESOLVED that the County of Monterey Board of Supervisors does hereby approve the amended Conflict-of-Interest Code of the Office of the County Counsel, County of Monterey, as submitted, attached hereto as Attachment A, and directs the Clerk of the Board of Supervisors to notify the Office of the County Counsel of the Board's approval.
