**AMENDMENT
TO
AGREEMENT FOR CARE, CUSTODY AND CONTROL OF CERTAIN RECORDS**

This Amendment to the Agreement for Care, Custody and Control of Certain Records (Amendment) is between the County of Monterey, a political subdivision of the State of California (County) and the Monterey County Historical Society, a California non-profit organization (Historical Society).

BACKGROUND

1. On June 21, 1983, the County and the Historical Society entered into an agreement for the care, custody and control of certain historical records (the Original Agreement).
2. Some of the records provided to the Historical Society under the Original Agreement properly belong to the Superior Court of California, County of Monterey (Court).
3. Some of the records on the inventory list attached to the Original Agreement were never provided to the Historical Society.
4. Some of the records on the inventory list attached to the Original Agreement were mislabeled.
5. The parties want to 1) remove records that belong to the Court from the terms and conditions of the Original Agreement; and 2) revise the inventory list to accurately reflect those records received and maintained by the Historical Society under the terms of the Original Agreement.

AGREEMENT

The parties agree to the following:

1. Exhibit A contains a revised and accurate list of the records that are subject to the Original Agreement.
2. Exhibit B contains a list of court records that were maintained by the Historical Society under the terms and conditions of the Original Agreement and now being removed from the control of the Original Agreement by this Amendment (Court Records).

3. Concurrent with the execution of this Amendment, the Historical Society will enter into a separate agreement with the Court for the care, custody and control of the Court Records.
4. All other terms and conditions of the Original Agreement not specifically amended by this Amendment remain in full force and effect.
