AMENDMENT NO. 4 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN COUNTY OF MONTEREY AND ICF JONES & STOKES, INC.

THIS AMENDMENT NO. 4 to the Professional Services Agreement between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and ICF Jones & Stokes, Inc. (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into a Professional Services Agreement with County on July 18, 2011 (hereinafter, "Agreement"); and

WHEREAS, Agreement was amended by the Parties on July 19, 2012 (hereinafter, "Amendment No. 1", including Exhibit A-1 – Revised Schedule), March 26, 2013 (hereinafter, "Amendment No. 2", including Exhibit A-2 – Revised Schedule), and September 9, 2013 (hereinafter, "Amendment No. 3", including Exhibit A-3 – Scope of Services/Payment Provisions); and

WHEREAS, Task 1, Review Greenhouse Gas (GHG) Reduction Target, Identify Strategies and Measures; Task 2, Municipal Climate Action Plan; and Task 3, Project Management, Meetings and Coordination, of the Climate Action Plan (CAP) for the County of Monterey Operations (hereinafter, "Project") have been completed; and

WHEREAS, additional time is necessary to allow CONTRACTOR to complete Task 4, Community Climate Action Plan, As Needed Support, for the Project on an "as needed" basis as requested by the County; and

WHEREAS, the Parties wish to further amend the Agreement to extend the term to September 30, 2015 with no associated dollar amount increase to allow CONTRACTOR to continue to provide services associated with Task 4 as identified in the Agreement.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

- 1. Amend the first sentence of Paragraph 3, "Term of Agreement", to read as follows:
 - The term of this Agreement is from <u>June 28, 2011</u> to <u>September 30, 2015</u>, unless sooner terminated pursuant to the terms of this Agreement.
- 2. All other terms and conditions of the Agreement remain unchanged and in full force.
- 3. This Amendment No. 4 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
