WHEREAS, Dr. Laura M. Solorio is retiring after twenty-eight years of public service from Natividad Medical Center and the Monterey County Health Department, Clinic Services Bureau, as a General Internist, and as a physician, she has devoted her career to provide dedicated and respectful service to thousands of patients, especially the underserved population of Monterey County; and

WHEREAS, Dr. Laura M. Solorio graduated from the University of California, San Francisco, School of Medicine, and completed an internal medicine residency at Kern Medical Center in Bakersfield, California, where she was Chief Resident; and

WHEREAS, Dr. Laura M. Solorio started providing patient care at Natividad Medical Center in 1986, and quality oversight as the Internal Medicine Services Director from 1996-2004, in 2004 she joined the Monterey County Health Department Clinic Services Bureau as an Internist, and was appointed Medical Director and Clinic Medical Director of the Laurel Internal Medicine Clinic, a Federally Qualified Health Center, she has remained committed to the mission of providing comprehensive primary and specialty care medical services, so that every resident of Monterey County has access to healthcare regardless of ability to pay, while insuring that services are of good quality and at the lowest possible cost; and

WHEREAS, Dr. Laura M.
