WHEREAS, the County and CONTRACTOR wish to further amend the AGREEMENT by adding \$80,581.00 for a new not to exceed amount of \$395,248.00 and extend the term of AGREEMENT by one (1) year with a new ending date of November 7, 2022

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

- 1. Section 3., "TERM OF AGREEMENT" shall be replaced with, "the signing of the AGREEMENT through and including November 7, 2022, with the option to extend the AGREEMENT for one (1) additional one (1) year period."
- 2. \$80,581.00 is added, for a new not to exceed amount of \$395,248.00.
- 3. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
- 4. A copy of the AMENDMENT shall be attached to the original AGREEMENT executed by the County on November 15, 2017.
