

WHEREAS, this action results in an increase and decrease of financial commitment of \$32,605 in the adopted FY 2018-19 Budget that is needed to support a temporary Management Specialist appointment to the CAO Intergovernmental & Legislative Affairs Division. The financial commitment decreases estimated appropriations to the County Administrative Office, Health Department-Environmental Health Bureau and Resource Management Agency.


