

**AMENDMENT #1 TO AGREEMENT
COUNTY OF MONTEREY AND
PALMER AUDIO, INC.**

THIS AMENDMENT #1 is made to the AGREEMENT (Agreement ID: 10/15/20 – 12/31/20) for audio visual services for the premier events in the **County of Monterey Standard Agreement** by and between **PALMER AUDIO EVENT SERVICES**, hereinafter “**CONTRACTOR**”, and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “**County**”; and

WHEREAS, the County executed the original AGREEMENT on October 22, 2020; and

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to reflect a name change for CONTRACTOR and an amendment to Exhibit A “Scope of Services” to the County of Monterey Standard Agreement Palmer Audio Event Services.

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

1. CONTRACTOR’S name shall change from Palmer Audio Event Services to Palmer Audio, Inc.
2. Section 2.0 “PAYMENT PROVISIONS” shall be amended by removing “**The total amount payable by County to CONTRACTOR under this Agreement shall not exceed \$38,000.00**” and replacing it with “**the total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$223,000.00**”.
3. Section 3.0 “TERM OF AGREEMENT” shall be amended by removing “**The term of this Agreement is from October 15, 2020 to December 31, 2020...**” and replacing it with “**The term of this Agreement is from October 15, 2020 to December 31, 2022...**”
4. Exhibit A, Section A1.2.14 to be amended to include the 2021 premier event schedule as follows:

July 9-11 (TBC)	GEICO Motorcycle MotoAmerica Superbike Speedfest at Monterey
July 16-18	AHRMA Monterey Classic MotoFest
August 7-8	Monterey Pre-Reunion
August 12-15	Rolex Monterey Motorsports Reunion
Sept 10-12 (TBC)	Hyundai Monterey Sports Car Championship
Sept 17-19	Firestone Grand Prix of Monterey

Event dates are subject to change. Additional events may be added.

5. Exhibit A, Section A1.2.14.1 shall be added as follows:

LSRA Manager will provide CONTRACTOR with the 2022 premier event schedule by December 1, 2021.

6. Exhibit A, Section A1.4.3 shall be added as follows:

County agrees to pay CONTRACTOR for services rendered within 30-45 days from the date a detailed, approved invoice is received by the County Auditor-Controller's office.

7. Exhibit B, "Pricing Per Term of Agreement" to be amended to include the following full-service events for 2021 and 2022 at the agreed upon prices noted. LSRA Manager to provide CONTRACTOR with an approved purchase order for each event where services are required.




