She served two years in the County Jail and was transferred to the Bailiff Unit, where she was assigned to the Salinas Courthouse entry screening station, as well as roving duties; and

WHEREAS, Deputy Barajas responsibilities as a roving deputy included maintaining the security of the Courthouse complex, its employees and the general public, which included responding to and investigating suspicious activities and making arrests, writing reports and assisting the general public; and

She was routinely called upon to fill in for her supervisors in their absence and handle their daily work schedules; and
