Renew approval and adoption of)
teleconferencing for all County of Monterey)
Eligible Subsidiary Bodies pursuant to)
Government Code section 54953.8.6.)

WHEREAS, California law created teleconferencing requirements for Eligible Subsidiary Bodies in Government Code section 54953.8.6, effective January 1, 2026; and

WHEREAS, an “Eligible Subsidiary Body” is defined as a Brown Act Legislative Body which serves exclusively in an advisory capacity, lacks authority to take final action, and further lacks primary subject matter jurisdiction on elections, budgets, police oversight, privacy, public library material access, or taxes or related spending proposals; and

WHEREAS, the Board of Supervisors has considered the circumstances of the County’s Eligible Subsidiary Bodies and finds teleconference meetings would enhance public access to County meetings, provided the Eligible Subsidiary Bodies notify the public of remote participation on Zoom,© Teams,© or similar teleconferencing platform in their agendas; and

WHEREAS, the Board of Supervisors further finds teleconferenced meetings would promote the attraction, retention, and diversity of Eligible Subsidiary Body members; and

WHEREAS, the Board of Supervisors has provided the public this opportunity to comment at the Board’s in-person meeting; and

WHEREAS, Government Code section 54953.8.6 requires the Board of Supervisors to reauthorize teleconferencing of Eligible Subsidiary Bodies every six months; and

WHEREAS, on January 13, 2026, the Board of Supervisors approved Resolution Number 26-170, authorizing the Eligible Subsidiary Bodies of the County of Monterey to meet remotely pursuant to Government Code section 54953.8.6 and the Board’s Resolution is set to end on July 8, 2026.

NOW, THEREFORE,

BE IT RESOLVED by the Board of Supervisors in and for the County of Monterey that the County’s Eligible Subsidiary Bodies may use teleconferencing pursuant to Government Code section 54953.8.6 until **December 9, 2026**.

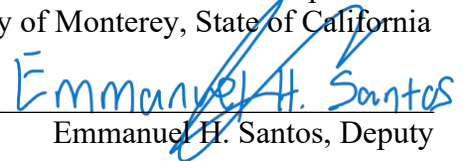
