**WHEREAS**, **Buck Jones** is responsible for notifications to the members of his platoon who served in Vietnam; and

**WHEREAS**, **Buck Jones**, since 2016, has been a volunteer van driver for the Monterey County Veterans Services Office Van Ride Program which transports veterans to and from their medical appointments at the Palo Alto VA Hospital.
