WHEREAS, Barbara Bannan earned her Medical Degree in 1988 at the University of Southern California Keck School of Medicine, served as an intern and resident at Natividad Medical Center in 1989 and 1991 respectively, and was certified by the American Board of Family Medicine to practice Family Medicine in 1991; and

WHEREAS, Barbara Bannan was the original healthcare provider at the Broadway Health Center in Seaside when it opened in 1992 as a small trailer clinic that served a few hundred patients a month; and

WHEREAS, through her extraordinary dedication to high quality, compassionate patient care, the clinic thrived and slowly gained acceptance, respect, cooperation and admiration within the greater medical community, including Community Hospital of the Monterey Peninsula, ultimately leading to the establishment of the Seaside Family Health Center, a clinic that now performs roughly 40,000 patient visits annually for the areas underserved residents, regardless of ability to pay; and

WHEREAS, Barbara Bannan has dedicated more than twenty years of faithful and honorable service as a physician to the improvement of health care in Monterey County by improving coordination between county clinics and local hospitals; and

WHEREAS, Barbara Bannan has demonstrated unparalleled service and unfailing commitment to improve the quality of life for underserved residents of Seaside and Marina communities, caring for generations of families, highly complicated patient cases; and
