**AMENDMENT NO. 4
TO PROFESSIONAL SERVICES AGREEMENT
BETWEEN COUNTY OF MONTEREY AND
TRC ENGINEERS, INC.**

THIS AMENDMENT NO. 4 to Professional Services Agreement No. A-12680 between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and TRC Engineers, Inc. (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into Professional Services Agreement No. A-12680 with County on April 21, 2015 (hereinafter, "Agreement") to provide bridge design services (hereinafter, "services") for the Hartnell Road Bridge Replacement, County Bridge No. 209 (hereinafter, "Project") through April 7, 2018 with the option to extend the Agreement for two (2) additional one (1) year period(s) for an amount not to exceed \$554,470; and

WHEREAS, Agreement was amended by the Parties on August 17, 2015 (hereinafter, "Amendment No. 1", including Exhibit A-1, Revised Rate Schedule) to update the Rate Schedule, effective April 7, 2015, with no extension to the term and with no increase in the not to exceed amount; and

WHEREAS, Agreement was amended by the Parties on March 8, 2018 (hereinafter, "Amendment No. 2") to extend the term for one (1) additional year through April 7, 2019 with no increase in the not to exceed amount; and

WHEREAS, Agreement was amended by the Parties on March 29, 2019 (hereinafter, "Amendment No. 3") to update the indemnification provisions and to extend the term for approximately thirty-three (33) additional months to December 31, 2021 with no increase in the not to exceed amount; and

WHEREAS, the additional right-of-way necessary to construct the Project has been successfully negotiated and acquired; and

WHEREAS, all regulatory permits for the Project have been obtained; and

WHEREAS, the Parties agree that the Rate Schedule in Exhibit A-1 – Revised Rate Schedule of the Agreement remains valid through December 31, 2021; and

WHEREAS, CONTRACTOR's Rate Schedule requires an update effective January 1, 2022; and

WHEREAS, additional services are required to address adjacent landowners' concerns in the design features of the Project and to satisfy the permitting requirements of the Regional Water Quality Control Board (RWQCB) for completion of the Project; and

WHEREAS, additional time and funding are necessary to allow CONTRACTOR to continue to provide services required by the County and for completion of the Project; and

WHEREAS, the Parties wish to further amend the Agreement to extend the term for one (1) additional year to December 31, 2022, to update the Rate Schedule, and to increase the amount by \$118,890 for a total amount not to exceed \$673,360 to allow CONTRACTOR to continue to provide services identified in the Agreement and as amended by this Amendment No. 4.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

1. Amend the first sentence of Paragraph 1., "Services to be Provided", to read as follows:

The County hereby engages CONTRACTOR to perform, and CONTRACTOR hereby agrees to perform, the services described in **Exhibits A, A-1 and A-2** in conformity with the terms of this Agreement.

2. Amend Paragraph 2., "Payments by County", to read as follows:

County shall pay the CONTRACTOR in accordance with the payment provisions set forth in **Exhibits A, A-1 and A-2**, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$673,360.00.

3. Amend the first sentence of Paragraph 3., "Term of Agreement", to read as follows:

The term of this Agreement is from April 7, 2015 to December 31, 2022, unless sooner terminated pursuant to the terms of this Agreement.

4. Amend Paragraph 4., "Additional Provisions/Exhibits", by adding "Exhibit A-2, Scope of Services/Payment Provisions".

5. The "Project Schedule" referenced in the Agreement, Exhibit A - Scope of Services/Payment Provisions, is hereby amended to extend through December 31, 2022, to conform to the amended term of the Agreement.

6. In all places within the Agreement, any reference to County's email address of RMA-Finance-AP-GP@co.monterey.ca.us for invoicing, is hereby replaced with RMA-Finance-AP@co.monterey.ca.us.

7. All other terms and conditions of the Agreement, including all Exhibits thereto, remain unchanged and in full force.

8. This Amendment No. 4 and all previous amendments shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.

9. The recitals to this Amendment No. 4 are incorporated into the Agreement and this Amendment No. 4.

Based on the results of the consultation with the Regional Water Quality Control Board (RWQCB), an extensive revegetation of the Hartnell Road Bridge Replacement, County Bridge No. 209 (Project) site is required as a condition of issuance of their 401 permit. Further, negotiations with landowners and utility companies has resulted in the requirement to design certain Project site improvements and coordinate certain utility relocations. Significant effort is expected to negotiate and satisfy these landowners as well as obtain right-of-way (ROW) certification to allow the Project to be constructed. This Amendment No. 4 addresses the requirements placed on the Project and will result in Plans, Specifications & Engineering Estimate (PS&E) and ROW certifications as well as securing full Federal Highway Bridge Program (HBP) funding to cover the costs incurred hereunder (100% reimbursement).

The CONTRACTOR’s Scope of Services for the Project consists of the following Phases:

1.7.7.3.1 Additional Coordination with Responsible/Cooperating Agencies and Other Stakeholders

COORDINATION

CONTRACTOR shall conduct conference call meetings with responsible/cooperating agencies and other stakeholders, the Design Team, and County to discuss Project-related impacts and avoidance measures, including Project design modifications and/or additional mitigation requirements. These agencies are expected to include Caltrans Environmental Staff, California Department of Fish and Wildlife (CDFW), Central Coast Regional Water Quality Control Board (CCRWQCB), and the United States Army Corps of Engineers (USACE), in addition to County. CONTRACTOR shall also coordinate through emails and phone calls, to clarify Project design details and issues, and to provide supporting information. This task includes participation in up to five (5) meetings or conference calls, including preparation of meeting materials and providing requested follow-up Project-related information and materials after the meeting. This task also includes time for internal team meetings to discuss agency and stakeholder information requests and time to research, review, describe and share requested information. A diversion/ dewatering plan shall be developed for use in obtaining environmental clearance and to facilitate fish passage during construction.

REVEGETATION PLAN

CONTRACTOR shall develop a revegetation plan document depicting required mitigation planting areas and plant counts as well as Geographic Information System (GIS) documentation of the different habitat areas. This document will be submitted to Caltrans and resource agencies for review and approval. Upon incorporation of agency comments and approval of the plan document, permit applications can be filed. LSA Associates, Inc., subconsultant to CONTRACTOR, will continue to provide environmental services for the Project.

CONTRACTOR shall develop revegetation plans and a cost estimate based on the revegetation plan approved under Task 1.7.7.3 of this Exhibit A-2. Selection of revegetation materials will utilize location-appropriate native planting palettes. It is anticipated that these plans shall include general areas of planting along with layout of specific plants using the Project survey and design plans as a basis. The plans will include design details for construction. The plans shall be submitted to County, Caltrans, CDFW, and CCRWQCB for review and comment. WRECO, subconsultant to CONTRACTOR, will continue to provide hydraulic services for the Project.

CONTRACTOR shall coordinate the team activities during the development of the revegetation plans and estimate. Consultation with Caltrans and resource agencies shall be performed to obtain approval of the P&E. Topographic surveys shall be performed to obtain data for the revegetation design as well as the additional ROW accommodation and utility relocation work described in other tasks hereunder. Whitson and Associates, Inc. dba Whitson Engineers, subconsultant to CONTRACTOR, will continue to provide surveying services for the Project. CONTRACTOR shall perform project management activities in implementing these additional services.

4.1 TEMPORARY BRIDGE OR CULVERT DESIGN

4.1.1 DEWATERING AND DIVERSION SYSTEM DESIGN AND PS&E

CONTRACTOR shall develop a dewatering plan and diversion system to route flow around the Project site during construction. The design will incorporate the existing detention pond on the parcel at the northeast corner of the Project. Coordination with the landowner will be required to implement the system and not interfere with landowner operations.

Total Amount Increase: \$12,000.00

4.1.2 ADDITIONAL UTILITY COORDINATION AND ROW ACCOMMODATION DESIGN

CONTRACTOR shall coordinate utility relocations required to accommodate the landowners on the northwest side of the Project as well as construction of the Project. Additional ROW will be required to accommodate the utility facilities. CONTRACTOR shall coordinate with County, landowners, and utility representatives in the course of this work. On the southeast side of the Project, CONTRACTOR shall design a gabion trench to protect the downstream creek bank as well as a small timber retaining wall to maintain access to a well point.

SHOULD A SUPPLEMENTAL SERVICE IDENTIFIED IN EXHIBIT A-2 BE REQUIRED, CONTRACTOR SHALL PRESENT THE COST ASSOCIATED WITH THE SUPPLEMENTAL SERVICE TO COUNTY PROJECT MANAGER AND WITH COUNTY PROJECT MANAGER'S WRITTEN APPROVAL, BE AUTHORIZED TO PROCEED. THE TOTAL COST FOR ALL SUPPLEMENTAL SERVICES SHALL NOT EXCEED THE AUTHORIZED SUPPLEMENTAL SERVICES BUDGET AMOUNT APPROVED UNDER THIS AGREEMENT WITHOUT AN EXECUTED AMENDMENT TO THIS AGREEMENT.

ANY ADDITIONAL SERVICES REFERENCED IN THIS EXHIBIT A-2 OF THIS AGREEMENT WHICH DO NOT INCLUDE A COST SHALL NOT BE PROVIDED BY CONTRACTOR UNLESS PRESENTED TO AND AUTHORIZED BY COUNTY IN WRITING VIA AN EXECUTED AMENDMENT TO THIS AGREEMENT.

PAYMENT PROVISIONS

PHASE 0, I, II, AND III - BASIC SERVICES:

1. CONTRACTOR shall be reimbursed for hours worked at the hourly rates specified in CONTRACTOR's Rate Schedule attached hereto. The specified hourly rates include direct salary costs, employee benefits, overhead, and fee.
2. In addition, CONTRACTOR shall be reimbursed for incurred (actual) direct costs other than salary and subconsultant costs. CONTRACTOR shall be reimbursed for subconsultant costs at actual cost.
3. Reimbursement for transportation and subsistence costs shall not exceed the rates as specified by County. CONTRACTOR shall receive compensation for travel expenses per the "Monterey County Travel and Business Expense Reimbursement Policy". A copy of this policy is available online at: <https://www.co.monterey.ca.us/home/showdocument?id=69364>. To receive reimbursement, CONTRACTOR shall provide a detailed breakdown of authorized expenses, identifying what was expended and when.
4. CONTRACTOR shall invoice monthly for payment of services provided and costs incurred, including actual hours worked by task, staff member and associated cost which was incurred during the previous month.

PHASE IV - SUPPLEMENTAL SERVICES:

The basis of payment for the Supplemental Services provided under this Agreement shall be at the standard hourly rates specified in CONTRACTOR's Rate Schedule attached hereto. The specified hourly rates include direct salary costs, employee benefits, overhead, and fee.

1. County shall reimburse CONTRACTOR at standard hourly rates as listed in the attached Rate Schedule.
2. CONTRACTOR shall be reimbursed for travel expenses incurred in accordance with Paragraph 3 above, under Basic Services.

TOTAL COMPENSATION

The specific rates of compensation specified in CONTRACTOR's Rate Schedule are not adjustable and are valid through the remaining term of this Agreement (December 31, 2022). A rate increase may be negotiated according to Section 13.0, Agreement Terms and Conditions, of RFQ #10490 – On-Call Bridge Design Services for Monterey County Bridge Projects.

For billing purposes work shall be segregated between Basic Services and Supplemental Services:

The total amount payable by County for work under this Agreement for Basic Services (Phase 0, I, II and III) in the amount of \$516,570 shall be increased by \$76,925 for a total not to exceed amount of \$593,495. Any further increase to the amount must be authorized by County through an executed amendment to this Agreement.

The total amount payable by County for work under this Agreement for Supplemental Services (Phase IV) in the amount of \$37,900 shall be increased by \$41,965 for a total not to exceed amount of sum of \$79,865. Any further increase to the amount must be authorized by County through an executed amendment to this Agreement.

The total amount payable by County for work under this Agreement for Basic Services and Supplemental Services is increased by \$118,890 for a total Agreement amount not to exceed

\$673,360, unless authorized by County through an executed amendment to this Agreement.
