WHEREAS, *Steve Snodgrass* resides in Royal Oaks, North Monterey County, with his wife, Gayle; and, they have two sons; and,

WHEREAS, *Steve Snodgrass* has worked for Granite Rock Company for the past 19 years as Controller, Chief Information Officer and currently serves as their Chief Financial Officer; and,

WHEREAS, *Steve Snodgrass* serves as the Treasurer for the United Way of Santa Cruz County Board of Trustees; and, he serves as the Finance Committee Chair; and, he serves on the Board of Directors of Pajaro/Sunny Mesa Community Service District; and, he is the elected independent Special Districts Member on the Local Agency Formation Commission for Monterey County (LAFCO); and,

WHEREAS, *Steve Snodgrass* was awarded the 2013 United Way of Santa Cruz County - Volunteer of the Year Award, because an important part of the mission of United Way includes volunteering and Steve embodies the true meaning of helping others.
