Approve and authorize the Director of Health Services or designee to execute up to three (3) future amendments that do not exceed 10% (\$59,052) of the original Agreement amount, do not significantly change the scope of services and do not increase the total not to exceed amount over \$649,572.

RECOMMENDATION:

It is recommended that the County of Monterey Board of Supervisors:

- a. Approve and authorize the Director of Health Services or designee to execute a Mental Health Services Agreement for a term beginning on the date of execution of the Agreement to June 30, 2027 with Remi Vista, Inc., for the provision of Short-term Residential Therapeutic Program (STRTP) treatment services including Case Management, Mental Health Services, Medication Support, and Crisis Intervention for children/youth in the amount of \$295,260 for FY 2025-2026 and \$295,260 for FY 2026-2027 for a total Agreement amount not to exceed \$590,520; and
- b. Approve and authorize the Director of Health Services or designee to execute up to three (3) future amendments that do not exceed 10% (\$59,052) of the original Agreement amount, do not significantly change the scope of services and do not increase the total not to exceed amount over \$649,572.

SUMMARY/DISCUSSION:

Remi Vista, Inc., is a Short-term Residential Therapeutic Program (STRTP) providing residential and specialty mental health services including specialized and intensive care, support, and 24-hour supervision on a short-term basis for children and youth with complex and severe needs. The goal of the program is to provide therapeutic interventions to treat and ameliorate the behavioral health symptoms and improve function so that children and adolescents may move to a less restrictive and intensive treatment setting.

This Agreement contains the County's standard 30-day "no cause" provision (Section V, B) and an additional defunding provision (Section V, D), which provides the County the ability to amend or terminate the Agreement in the event of a reduction and/or termination of funding.

Goal(s): 2) Provide Exceptional Person-Centered Care through Accessible, Community-Focused Health Services. It also supports one of the ten essential public health services, specifically: (7) Link people to needed personal health services and assure the provision of health care when otherwise unavailable.

OTHER AGENCY INVOLVEMENT:

The Office of the County Counsel and Auditor-Controller have reviewed and approved this Agreement as to legal form and fiscal provisions, respectively.

FINANCING:

This Agreement is funded by 2011 Realignment (50%) and Federal Financial Participation (50%). The funds for this Agreement for FY 2025-2026 are included in the Health Department's Behavioral Health (HEA012, Unit 8410) adopted budget. The funds for FY 2026-2027 will be included in the Health Department's Behavioral Health (HEA012, Unit 8410) FY 2026-2027 Requested Budget.
