Mark Rispoli provides a level of service, in this field, which no other trainer/vendor, in Monterey County Provides. Makor K9 also provides K9 services to several other adjoining jurisdictions, to include many Federal agencies.

Mark Rispoli, proprietor of Makor K9, is a certified k9 trainer in both Detection and Patrol Service K9s. He is recognized by California Narcotics Canine Association (CNCA) as a certified Trainer. CNCA is a professional association recognized by California Police Officer Standards and Training (POST). Post establishes California Police K9 Standards based on input from CNCA as well as other K9 associations.

c) Why are these specific features/qualifications required?

The MCSO would prefer to retain the services of Makor K9, for an additional contract period. The MCSO maintains high standards for K9 training and deployment, which Makor K9 is instrumental in that process. Makor K9 provides these services at a competitive price.

 Prior to MCSO contracting with Makor K9, multiple K9 companies were interviewed. Makor K9 was chosen for several reasons to include reliable reputation, pricing, services offered as well as a tailoring of training and scheduling needs of MCSO.
