**WHEREAS**, the County of Monterey has incorporated the Federal Emergency Management Agency’s “Whole Community” approach to creating engaged and resilient communities by which we can understand the unique and diverse needs of our population including its demographics, values, norms, networks and relationships. These values are reflected in the Annexes; and

**WHEREAS**, the Annexes address all hazards and vulnerabilities in alignment with the 2014 Monterey County Operational Area Emergency Operations Plan and 2016 Multi-Jurisdictional Hazard Mitigation Plan; and

**WHEREAS**, the County of Monterey has reviewed the Annexes and affirms that the Annexes will be updated no less than every 3 years upon adoption.
