## Amendment No. 3

To

## Health Information Exchange Provider Participation Agreement By and between

## County of Monterey, on behalf of the Health Department and Central Coast Health Connect, LLC ("CCHC")

This Amendment No. 3 is made and entered into, by and between the County of Monterey, a political subdivision of the State of California, on behalf of its Health Department, hereinafter referred to as "Provider Participant", and Central Coast Health Connect, LLC., a California limited liability company with its principal place of business at 10 Ragsdale Dr. Suite 102, Monterey, CA 93940, hereinafter referred to as "CCHC or "HIO".

## **RECITALS:**

WHEREAS, the Provider Participant and CCHC have heretofore entered into a Health Information Exchange Provider Participation Agreement to allow County participation into the Monterey County Health Information Exchange ("HIE") for the period of September 15, 2016 to June 30, 2018 ("Agreement"); and

WHEREAS, on July 1, 2018, the County and CCHC entered into an executed Amendment No. 1 to extend the term of the Agreement for one (1) additional year for a new term of September 15, 2016 to June 30, 2019; and

WHEREAS, on July 1, 2019, the County and CCHC entered into an executed Amendment No. 2 to extend the term of the Agreement for one (1) additional year for a new term of September 15, 2016 to June 30, 2020; and

WHEREAS, Provider Participant and CCHC wish to amend the Agreement to extend the term of the Agreement for one (1) additional year, as specified below.

NOW THEREFORE, the Provider Participant and CCHC hereby agree to amend the Agreement, as follows:

- 1. The term of the Agreement shall be extended for an additional one (1) year period to June 30, 2021 for a new term of September 15, 2016 to June 30, 2021.
- 2. Except as provided herein, all remaining terms and conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 3 and shall continue in full force and effect as set forth in the Agreement.
- 3. A copy of this Amendment No. 3 shall be attached to the Agreement.
- 4. The effective date of this Amendment No. 3 is July 1, 2020.
