RENEWAL AND AMENDMENT NO. 1 TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY AND MEarth

THIS RENEWAL AND AMENDMENT NO. 1 to the Agreement is made by and between the County of Monterey, a political subdivision of the State of California (hereinafter referred to as "County"), and **MEarth** (hereinafter referred to as "CONTRACTOR") with respect to the following.

WHEREAS, on March 5, 2020, the COUNTY and CONTRACTOR entered into an Agreement for the provision of School Day field trips addressing healthy foods, healthy food choices, handson organic garden experience, and food preparation for students for the term of January 27, 2019 through September 30, 2022 and in the amount of \$48,393; and

WHEREAS, the Agreement expired by its terms on September 30, 2022; and

WHEREAS, the County and Contractor have since continued to perform under the Agreement and otherwise conduct themselves as if it remained in force; and

WHEREAS, the County and Contractor mutually desire to reinstate the Agreement with effect retroactive to October 1, 2022; and

WHEREAS, the County and CONTRACTOR wish to renew and amend the Agreement on the same or similar terms, to extend the term for an additional one (1) year period through September 30, 2023, to allow services to continue with no change to the Scope of Services and to increase funds by \$16,000 for a new AGREEMENT amount not to exceed \$64,393

NOW THEREFORE, the County and CONTRACTOR hereby agree as follows:

- 1. The Agreement shall be, and hereby is, retroactively reinstated in its entirety as of October 1, 2022 and shall be, and shall be considered to have been, at all relevant times as provided herein, in full force and effect as if the same had never expired.
- 2. <u>Section 2.0</u>. Section 2, PAYMENT PROVISIONS, is hereby amended and restated to read in its entirety as follows:

"2.0 PAYMENT PROVISIONS:

County shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set forth in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$64,393."

- 3. Section 3.01. Section 3.01 is hereby amended and restated to read in its entirety as follows:
 - "3.01. The term of the Agreement is from **January 17, 2019**, to **September 30, 2023**, unless sooner terminated pursuant to the terms of this Agreement. This Agreement is of no force or effect until signed by both CONTRACTOR and County and with County signing last, and **CONTRACTOR may not commence work before County signs the Agreement**.
- 4. Except as provided herein, all remaining terms, conditions, and provisions of the Agreement

are unchanged and unaffected by this Renewal and Amendment No. 1 and shall continue in full force and effect as set forth in the Agreement.
