SUMMARY:

Written Reports are filed each year for County Service Areas requiring service charges. The Board of Supervisors receives these reports. This action is necessary to collect service charges on the County tax rolls. No new or increased service charges are proposed to be placed on the County tax rolls for those County Service Areas covered by this report. Exhibit A – Description of Services describes the services for County Service Areas as of May 2, 2011 (see attached).

DISCUSSION:

Ordinance No. 2516 created the procedure for establishing service charges for County Service Areas (CSAs), was adopted on May 8, 1979, requiring an annual written report and noticed Public Hearing. These service charges are not subject to Prop 218 because no new or increased service charges are proposed to be placed on the County tax rolls for those County Service Areas covered by this report.

The Clerk of the Board has reserved June 14, 2011, for the Public Hearing. In addition to service charges placed on the County tax rolls, property owners in CSA 75 are also assessed a monthly user fee for sanitary sewer services. The monthly user fee has not been adjusted for inflation in over a decade. As a result, CSA 75 has been operating with a negative cash flow for many years, and the reserve balance has diminished to a critical level. A rate study is in progress to determine the appropriate funding level to manage the sewer system. It is anticipated that there will be a resultant monthly user fee increase for sanitary sewer services in CSA 75 presented to the Board of Supervisors before the next fiscal year.

OTHER AGENCY INVOLVEMENT:

Service charge schedules are sent to the Auditor-Controller and the Treasurer-Tax Collector for inclusion in the property tax bill. Some CSAs have advisory committees. The Department of Public Works meets with these advisory committees to review the proposed budgets and receive recommendations regarding the proposed budgets and service charges for the service area. CSAs collecting service charges on the tax rolls that have active advisory committees are as follows:

CSA 15 - Toro Park/Serra Village

CSA 45 – Oak Hills

CSA 50 - Lower Carmel River

FINANCING:

Service charges provide revenue for the proposed budgets for CSAs. The approximate annual service charge for a typical single-family dwelling in each area is shown on the attached Exhibit B – Table of Services.
