Renewal, Extension and Amendment No. 1 to Statement of Work No. 10

This Renewal, Extension and Amendment No. 1 ("Amendment") to Statement of Work No. 10 ("Statement of Work") issued pursuant to a Master Services Agreement dated as of April 7, 2008 (the "Agreement") between the County of Monterey ("Customer" or the "County"), a political subdivision of the State of California having a place of business at 168 W. Alisal Street, 3rd Floor, Salinas, CA 93901, and CGI Technologies and Solutions Inc. ("CGI"), a Delaware corporation having its principal place of business at 11325 Random Hills Road, Fairfax, Virginia, 22030.

WHEREAS, the County and CGI entered into the Statement of Work effective January 25, 2012;

WHEREAS, the County and CGI agree to modify certain terms and conditions of the Statement of Work;

NOW, THEREFORE, IT IS AGREED BY AND BETWEEN THE PARTIES HERETO:

1. <u>Effective Date of this Renewal, Extension and Amendment to Statement of Work.</u> Statement of Work No. 10 is renewed and extended from December 30, 2012 to a new end date of December 31, 2013.

2. Services to be Performed and Schedule of Performance for Amendment No 1.

This Amendment to Statement of Work is to provide additional 530 (five hundred and thirty) hours of professional services, as requested by the County, to support the configuration of changes in the payroll system, provide general Advantage ERP Systems support reports and consulting. This includes transfer of knowledge transfer and assistance with Active Directory 2008. The total number of hours on the Statement of Work will now be 1330 (one thousand three hundred and thirty) hours.





3. <u>Compensation.</u>

CGI will provide professional services at the standard hourly rate of \$190, inclusive of travel and other reimbursement expenses.

The maximum amount billable under the amended Statement of Work increases from \$152,000 (one hundred fifty-two thousand dollars) to a new not-to-exceed amount of \$252,700 (two hundred fifty two thousand and seven hundred dollars).

CGI is neither authorized nor obligated to expend additional effort beyond the amount authorized herein without the mutual agreement of the parties and the execution of an amendment to the Agreement.
