WHEREAS, on December 16, 2008, the Board of Supervisors approved Board Resolution No. 08-373 authorizing the Chief Probation Officer to sign and submit an application for a local juvenile detention facility SB 81 construction grant in the amount of \$35 Million, and made other necessary and appropriate findings and declarations supporting the SB 81 construction grant application;

WHEREAS, the application for a 150-medium-security bed facility was submitted and found worthy of funding at the Corrections Standards Authority (CSA) Board Meeting in March 2009;

WHEREAS, the Board of Supervisors on January 15, 2014, approved Board Resolution No. 14-014 approving the existing Juvenile Hall site, located at 1420 Natividad Road, Salinas, CA, as the proposed site for a new Juvenile Hall facility to comply with the site assurance requirements pursuant to Senate Bill 81 (SB81), Local Youthful Offender Rehabilitative Facility Construction Financing Program;

WHEREAS, the Board of Supervisors on April 22, 2014, approved Board Resolution No. 14-106 approving submission of revised Project Scope, Cost, and Schedule by the Chief Probation Officer to the Board of State and Community Corrections (BSCC) for approval;

WHEREAS, BSCC approved the revised project Scope, Cost, and Schedule on May 8, 2014; and

WHEREAS, the County due to the Project's large scope, specialized corrections construction components, and aggressive schedule, determined that prequalification of contractors was vital to the success of the Project; and

WHEREAS, on October 8, 2015, RFQ 10550, Request for Contractor Prequalification for the New Juvenile Hall, Project No. 8811, was advertised to contractors interested in bidding on the Project's construction contract to submit qualifications packets; and

WHEREAS, the County following the California Department of Industrial Relations guidelines for Prequalification of Contractors has evaluated all submittals based on each contractor's qualifications and experience record in delivering correctional projects of a similar size and scope to the County's Project, on budget, on schedule, and of proven construction quality, and established a List of Prequalified Contractors Eligible to Bid for the Construction Contract for the New Juvenile Hall, Project No. 8811; and

WHEREAS, the County and DLR Architects have now completed preparation of the Working Drawings (Plans and Specifications) for BSCC approval for the construction of the New Juvenile Hall facility; and

WHEREAS, approval of this recommended resolution provides for the required submission of Working Drawings (Plans and Specifications) to the BSCC to seek State approval to Proceed to Bid.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of the County of Monterey as follows:
