WHEREAS, *David W. Pratt (Dave)* began his career with the County of Monterey on July 10, 2006, with the Department of Public Works as a Management Analyst III responsible for a wide variety of administrative analytical duties of moderate to high scope and complexity; and

WHEREAS, *Dave* was reclassified to Project Manager II in March 7, 2015 and promoted to Project Manager III on September 25, 2022 for the Public Works, Facilities and Park Department responsible for planning, coordinating, and managing capital projects of varying level of complexity, size and impact, to ensure adherence to timelines, budget and contract administration; and

WHEREAS, *Dave* on April 20, 2024 was promoted to Working Out of Class as the Capital Improvement Manager overseeing County-wide capital improvement projects and leadership of related County staff and contractors until November 16, 2024; and

WHEREAS, *Dave*'s hard work, skill, dedication and leadership has been a tremendous asset to the County; and

WHEREAS, *Dave* excelled at executing all his assignments and capital improvement projects with efficiency and effective leadership including the Share Center Emergency Shelter Project completed in 2021, and most recently the completion of over a dozen American Recovery Program Act (ARPA) road, sewer, water improvement projects, the San Ardo Public Works Maintenance Office remodel, major improvement to the Health Department's 1270 Natividad Administration facility and the Pajaro Debris Removal Project for which; and

WHEREAS, *Dave* received commendation for his efficient mobilization and coordination of contractors to assist with the Pajaro community cleanup efforts after the March 2023 storm and flood; and

WHEREAS, *Dave*, during his many years of service, earned the admiration and respect of his co-workers, colleagues in the field and throughout the various County Departments through service performed in an impeccable fashion, efficiency and effective leadership including implementing all of his assigned County Capital Improvement projects with utmost professionalism; and
